PARTNERSHIP AGREEMENT

3.7. In the event of a serious breach of the Agreement by a Party, the other Party may terminate the Agreement with immediate effect.

3.8. In the event that new legislation enters into force in the Republic of North Macedonia that changes the term of education and professional qualification, the provisions of the legislation in force shall apply in this Agreement on the date of the change.

The Agreement shall be signed in English in triplicate, each of which shall be legally binding.

3.9. THIS AGREEMENT HEREBY IS TERMINATED:

3.9.1. Upon expiry of the agreed term;

3.9.2. By mutual agreement between the Parties expressed in writing;

3.9.3. Unilaterally by the Party in default of the other Party
